## LEGAL REMINDERS:

## The BIG 3

#### ONE:

Smoke Free Policy Reminder: On December 5, 2016, HUD published a final rule for each Public Housing Agency ("PHA") administering low-income, conventional public housing to initiate a smoke-free policy. The effective date of the Rule was February 3, 2017, and it provided an 18-month implementation period. All PHAs were required to have a smoke-free policy in place by July 31, 2018. SMHA's Smoke Free Public Housing Policy has been in effect since April 1, 2018. SMHA tenants and members of the tenant's household shall not smoke anywhere in the dwelling unit rented by tenant, in the building where tenant's dwelling unit is located, in any common areas or on any adjoining exterior property owned by SMHA, nor shall tenant permit any guests or visitors under the control of the tenant to do so (Dwelling Lease, Section 11).

#### TWO:

<u>Serious Criminal Activity</u>: SMHA has a One Strike policy regarding criminal activity and drug-related activity. No tenant or member of the tenant's household shall engage in any criminal activity, whether that activity occurs on the leased premises, on or near the housing development of which the leased premises is a part, or in any other locations whatsoever. Criminal activity shall include, but not be limited to:

- Physical Assault
- Threat of Physical Assault
- Illegal use and or possession of a firearm or other weapon
- Threat to illegally use a firearm or other weapon
- Possession, manufacture, sale, distribution or use of a controlled substance
- Sexual Molestation, Prostitution and other similar related serious misconduct


### THREE:

<u>Annual Re-Examinations</u>: Once a year SMHA will send out a notice to all tenants reminding them of their requirement to recertify to show that they are still eligible to receive housing benefits. All documents must be returned on or before the deadline provided on the notice. Failure to sign, date and return all of the documents by the assigned date constitutes a violation of the Dwelling Lease and can result in an eviction against the tenant.
